



## Charles Cheesman

May 7, 1921 - August 30, 2009

Charles Cheesman, 88, of Harrodsburg died on Sunday, August 30, 2009 at Westview Nursing and Rehabilitation Center in Bedford. He was born on May 7, 1921 in El Paso, TX the son of Harlos and Melvina (Delarma) Cheesman. He attended Lincoln High School in Winchester, Indiana and entered the U.S. Marine Corps. Dec. 2, 1942 and served in the Pacific Theater during World War II.

Upon his discharge from the Marine Corps he attended Earlham College in Richmond, IN and the University of Arkansas. It was during this time that he became employed as a Right of Way Agent and began a longtime association with the pipeline and public utility industries. Not only did he work for various pipeline companies but also Indiana Bell Telephone Co. and Hoosier Energy. During his years of purchasing right of way, he also was active in professional rodeos throughout the southwest, often times on the weekends.

Charles was a member the Veterans of Foreign Wars, the American Legion, the American Right of Way Association and the Monroe County Saddle Club.

Survivors include his wife, Phyllis J. (Davis) Cheesman of Harrodsburg, two sons and daughters-in-law; Nicholas and Terri Cheesman of Boonville, IN and Pat and Brenda Cheesman of Mt.
