Helen Frances (Eads) Patton, 91, of Bloomington, went to her Heavenly home on Friday, December 23, 2022. She passed away at Hearthstone Health campus surrounded by her loving family.

Helen was born October 16, 1931, at her home in southern Monroe County. She was the daughter of James M. Eads and Bessie (Deckard) Eads. Helen grew up near the Nancy Jane Bridge in the Allens Creek area now covered by Lake Monroe. Helen attended Allen's Creek, a one-room school along with her siblings, then Smithville High School. After graduation, she moved to Bloomington and worked at Sarkes Tarzian factory. She met Paul E. Patton in October 1949, and they married June 9, 1950. Paul and Helen were married for 44 years before he passed away on October 17, 1994.

After Paul's death, Helen became very independent and lived by herself until just a couple of weeks ago. She and her little white Bichon dog Buddy were great companions.
